

A 600-acre, low down payment residential development plan to provide living accommodation for as many as 26,730 persons in various income brackets has been proposed for Blair Rifle Range by Burnaby-Seymour Liberal candidate Ray Perrault.

LOUGHEED PROJECT STARTED

Edper Investments Ltd., a large investment trust controlled by Edward and Peter Bronfman of Montreal with substantial holdings in Canada and the United States today announced the start of construction of the Lougheed Mail Shopping Centre, largest centre in Western Canada, to open in late August of 1969. Mr. Andre R. Bruneau, Vice-President in charge of real estate. stated that the shopping centre which will service the areas of Burnaby, Coquitiam, Port Coquitlam, Port Moody, New Westminster, Surrey and other areas within easy driving time will be located at the junction of North Road and Lougheed Highway in the Municipality of Burnaby. The centre will contain 600,000 sq. ft. of space.

Lougheed Mall

Lougheed Mall will be an enclosed mall shopping centre and will be a first for the Vancouver area insofar as it will contain both a Hudsons Bay Department store and a Woolco Department Store as well as two full levels of enclosed climatized shopping. containing a wide range of fashion and specialty shops, the food store in the centre will be Canada Safeway Ltd.

Hudson's Bay

The Hudson's Bay Company will operate a full line 125,000 square foot store in the centre. will be the Company's third store in the Vancouver area, joining The Bay downtown and a new store in Richmond, presently under construction and scheduled to open in the spring of 1969. The appeal of the store's merchandise will be in keeping

Mr. Cadieux emphasized that this store will follow the usual Wool-co pattern of self selection merchandise, providing customers with wide aisles for added customer shopping convenience. In announcing this new location. Mr. Cadieux stressed that further locations are being studied in the Vancouver market area and that the new Lougheed Mall will compliment the Woolco store already existing at Capilano Mall. North Vancouver.

Mr. W. J. Kraft, the chairman of the board of Canada Safeway Ltd., was pleased to announce Safeway's association with the Hudson Bay Co. and Woolco Department Stores in what will be the largest and most complete regional shopping centre in B.C. He promised that the Safeway

The two levels will be connected by Western Canada's first moving sidewalk in addition to escalators and stairways.
